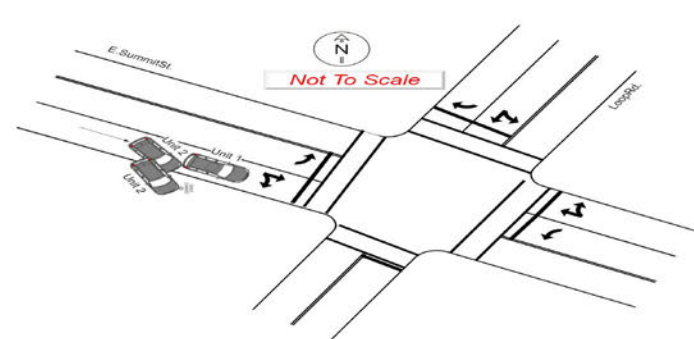
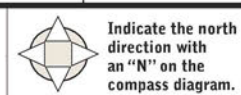

UNIT 1 WAS TRAVELING EAST BOUND ON E. SUMMIT ST. APPROACHING LOOP RD. AND BEGINNING TO SLOW DOWN. UNIT 2 WAS TRAVELING BEHIND UNIT 1 AND FAILED TO LEAVE ENOUGH DISTANCE BETWEEN HER AND UNIT 1 CAUSING THE ACCIDENT. ATTEMPTING TO AVOID THE ACCIDENT UNIT 2 DROVE OFF THE ROAD RIGHT AND STRUCK A UTILITY POLE (228904D 53933).

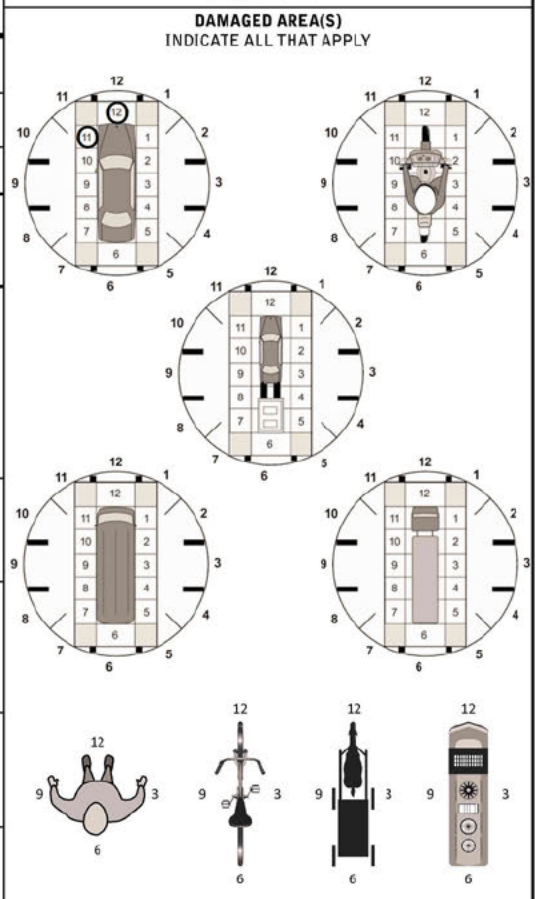
