At Council's request the staff have scheduled Committee time for Council to consider proposed changes to the City Clerk job description and parliamentary status. (attachment)



Community Development Committee

6. Proposed Changes to Parking Permits in North End of Downtown

Tom Wilke and Jim Bowling have requested Committee time to present Council with a recommendation from the Parking Action Committee to eliminate the permit parking used in and around the Columbus Street municipal parking lot. This proposal represents the final component of the City's comprehensive parking plan that was approved by Council as part of the downtown redevelopment. With the elimination of the permit parking, the permit spots would be re-posted for free, 2 hour parking. This should eliminate some customer confusion and expand the amount of free parking in downtown Kent. (attachment)



The Parking Action Committee and the staff recommend Council's support of this final component of the comprehensive downtown parking plan.

8. City of Kent/City of Tallmadge Memorandum of Understanding

Chief Lee has been working with her Police colleagues in the City of Tallmadge to draft a Memorandum of Understanding (MOU) that would allow for the shared use of the City of Kent's Police shooting range. Chief Lee reports that the draft MOU limits the times that Tallmadge officers can use the facility so as to not hinder Kent officers training and Tallmadge has agreed to pay \$300 a year for the rights to use the facility per the terms of the conditions outlined in the MOU. Administration Recommendation

The sharing of training resources to limit costs is an objective of all City services and given the productive partnerships that Kent Police have formed with neighboring cities, including Tallmadge, I recommend Council's support of the proposed MOU.

Council Actions


Approve the proposed Memorandum of Understanding with the City of Tallmadge for the shared use of Kent's training range as presented.







Streets, Sidewalk & Utilities Committee





Jim Bowling is requesting Council's consideration of a request to tie-in City water service to a new restaurant, Raising Cane's, on SR59. This out parcel on the Campus Point property has previously been served by City Water and the City Engineering Division have determined that the water lines in-place are adequate to meet the needs of the new restaurant. Administration Recommendation

Adding water service outside the City requires Council authorization and I recommend Council's approval.

Council Actions

Authorize the water extension and tie-in for Raising Cane's as presented.

10. 2018 Main Street Event Street Closure Requests



Tom Wilke has requested Committee time for Council's consideration of the expansion of 3 Main Street Kent events in 2018 that require Council's approval for expanded street closures. The Art & Wine Festival, Oktoberfest, and the Wizardly World events have become so popular that Main Street would like Council's authorization to provide more areas for attendees to participate in the events. Administration Recommendation

The City's Traffic Safety Committee members have reviewed the street closure requests and given the size of the crowds that have been attending the events, the staff recommends Council's support for the expanded street closures. Kent's economic recovery has largely been a result of the popularity of these events and the new dollars they bring to our local business so I urge Council's support.

Council Actions

Approve the proposed expanded street closures requested by Main Street Kent for the 2018 Art & Wine Festival, Wizardly World and Oktoberfest events.
