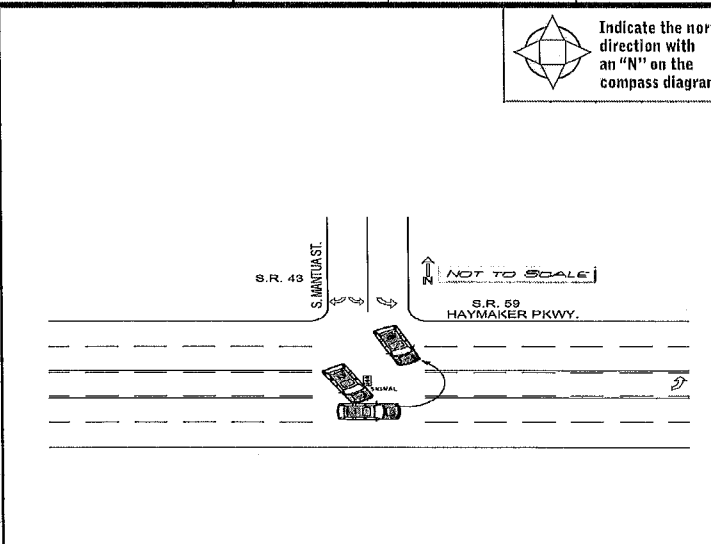

**Unit 1 was eastbound on SR 59 in the inside lane and passed through the red light at SR 43 (N Mantua St.) Unit 2 was making a left hand turn onto SR 59 from southbound on SR 43 in the right lane. Unit 2 struck unit 1 in the left side. Unit 1 then rotated left approx. 120 degrees. Unit 1 was then struck in the right front by Unit 3 which was turning left onto SR 59 from southbound SR 43 in the left lane.**

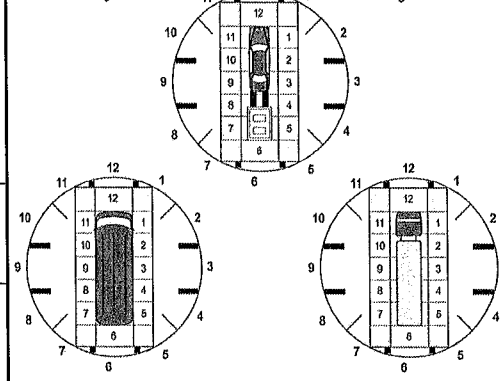
