

RESOLUTION NO. 2023-087

A RESOLUTION OF COMMENDATION AND APPRECIATION TO THE HONORABLE GARRET FERRARA FOR THE GENEROUS CONTRIBUTION OF HIS TIME AND TALENTS AS WARD 1 COUNCIL FOR THE PAST TWENTY-FOUR YEARS.


