ORDINANCE NO. 2023-031

AN ORDINANCE AMENDING SECTION 353.02 "PARKING REGULATION AUTHORIZATION" OF THE CODIFIED ORDINANCES OF THE CITY OF KENT TO CHANGE THE PERMISSIBLE PARKING CONDITIONS ON CUYAHOGA STREET ADJACENT TO THE OLD H-W INDUSTRIES BUILDING, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Kent wishes to modify Section 353.02 "Parking Regulation Authorization" of the Codified Ordinances to change the permissible parking conditions on Cuyahoga Street adjacent to the old H-W Industries building; and

WHEREAS, the existing ordinance prohibits parking on the south side of Cuyahoga Street only at H-W Industries. The new owner of the property has requested that this isolated condition be changed to be consistent with the parking conditions along the rest of Cuyahoga Street; and

WHEREAS, the Traffic Engineering and Safety (TE&S) Committee reviewed this matter and has no concern with the change.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio:

<u>SECTION 1</u>. That Kent City Council does hereby amend Section 353.02 "Parking Regulation Authorization" of the Codified Ordinances to change the permissible parking conditions on Cuyahoga Street adjacent to the old H-W Industries building to read as follows:

CURRENT LANGUAGE:

CUYAHOGA ST

NO PARKING NORTH SIDE, NO PARKING SOUTHSIDE FROM MANTUA ST. TO BEHIND H-W INDUSTRIES

NEW LANGUAGE:

CUYAHOGA ST

NO PARKING NORTH SIDE

<u>SECTION 2</u>. that it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 3</u>. this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
