ORDINANCE NO. 2023 - 022

AN ORDINANCE AUTHORIZING THE CITY OF KENT TO SUBMIT A FUNDING APPLICATION FOR A TRANSPORTATION IMPROVEMENT DISTRICT (TID) GRANT TOTALING \$0.5 MILLION, AND TO ACCEPT THE GRANT, IF AWARDED, WITH CORRESPONDING APPROPRIATION OF FUNDS FOR THE EAST MAIN STREET AREA IMPROVEMENTS, AND DECLARING AN EMERGENCY.

WHEREAS, the East Main Street Area Improvement Project has currently received \$15.845 million in Federal/State funding from six different areas in need; and

WHEREAS, the current project budget has recently increased due primarily to inflation and has increased the project amount to \$24 million; and

WHEREAS, this grant request will reduce the funding gap caused by the recent spike in inflation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio:

<u>SECTION 1.</u> That Kent City Council approves submission of the City's pre-application request for the TID grant funding totaling \$0.5 million and authorized the Administration to provide all information, funds, and documentation required in said applications for submission.

<u>SECTION 2.</u> That Kent City Council hereby approves the City's acceptance of the grant, if awarded to the City, with corresponding appropriations for its use.

SECTION 3. That Kent City Council hereby understands and agrees that participation in the TID grant program will require compliance with program guidelines and assurances.

<u>SECTION 4.</u> That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 5.</u> That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
