Main Street Kent 2013 Q1-Q3 Goals & Accomplishments

<u>Events/Marketing Activity</u> — Main Street Kent's marketing efforts are geared toward bringing people from Kent and surrounding communities here to shop, eat, and experience downtown Kent. Over the first three quarters of 2013, we have executed the following:

Chocolate Walk – Feb. 9: Two hundred tickets were sold at \$15 each. Twenty-four downtown businesses
participated in the event. Ticket holders toured downtown Kent, receiving a chocolate treat at each
location. Business owners reported seeing lots of new faces, increased sales, and an overall successful
event. All proceeds benefited Main Street Kent. We will repeat this event in Feb., 2014.







- Art & Wine Festival June 1: Wine tasting, art, food, and live music filled the downtown for the seventh year! Thousands of people attended this popular event, and area businesses reported significantly more profitable days as a result of the event. All proceeds benefited Main Street Kent. We're already gearing up for the 2014 event, scheduled for June 7th.
- <u>Discover Downtown</u> Aug. 19: In partnership with the KACC, this annual welcome event for incoming students is a great opportunity to help get them acquainted with the businesses in the downtown. Main Street Kent coordinates a scavenger hunt where students have to go to several businesses to find the correct answer to a specific question. Completed answer sheets are entered into a drawing for many downtown gift cards. Business owners hear customers say months later that they discovered their business during this event.
- International Festival Sept. 14: Our third year putting on this event, downtown Kent was turned into a multicultural experience including live entertainment, international flavors, and an interactive mural for the community to create. This mural is now on exhibit in the front window at Young & Associates on E. Main Street. A passport excursion was offered to attendees who could go to nineteen different businesses for a cultural experience food samples, art exhibits, crafts, etc. Businesses reported heavy traffic all day and into the evening, with some reporting high sales comparable to those reached during Heritage Fest in July.





- <u>Family Friendly Halloween</u> Thirty-four downtown businesses participated in this year's event, where families were able to trick-or-treat, do Halloween-themed crafts and play games at Earl's Nest and Hometown Bank Plaza. This was a great opportunity for people to preview where they will shop for the holidays.
- Thursday Night Live Concerts These summer concerts were held at the Hometown Bank Plaza, and were sponsored by local eateries who handed out free samples of their food at the concerts (along with menus and other "freebies.") This gave the community a chance to try different foods and enjoy live local music. Event-goers were seen eating treats from many nearby places as well such as ice cream, popcorn, etc., supporting local businesses exactly as planned!
- <u>Sidewalk Sale</u> July 20: Though the weather didn't cooperate, businesses reported an increase in foot
 traffic and expressed interest in doing more of these group effort sales. We will plan accordingly in the
 spring and summer next year.

Upcoming Events

- <u>Friday, Nov. 29th Black Squirrel Friday</u> This year we're planning an alternative to shopping the malls!
 We're planning an event in partnership with College Town Kent to include: live music, free gift wrapping, cookies and coffee, caroling, special deals and contest, and more.
- Saturday, Nov. 30th Small Business Saturday / Sweet Finds Contest
 For the second year, we will promote shopping locally on Small Business Saturday with a promotion called the "Sweet Finds Contest." Shoppers can go on a "hunt" in downtown Kent businesses to find a hidden "sweet treat" (picture of a gingerbread man, candy cane, etc.) and enter their completed entry forms in a drawing for gift cards.

Advertising

<u>TV</u> - Working with TV2, we developed a TV commercial and rolled out a Time Warner Cable TV blitz during June and September, prior to "back to school" and the International Festival, airing mostly in communities surrounding Kent, and some in Kent. The commercial highlighted many favorite shops and eateries in Kent, and was designed to attract people to come explore the newly redeveloped downtown. You can view the commercial here -

- <u>Facebook & Twitter</u> Daily updates about community events, business promotions, random acts of art, exciting happenings, new products, and other relevant information about downtown Kent. - Website Mainstreetkent.org is updated on a weekly basis to reflect current information regarding
 businesses and downtown activities; also featuring different businesses on the homepage every other
 week. The homepage has direct links to KSU and the Kent State Hotel, and live feeds from local venues
 offering live entertainment Stone Tavern, Kent Stage, & JB's. KSU is linking an upcoming ad campaign
 focused on downtown Kent to our website! www.mainstreetkent.org
- <u>Akron Life</u> The November issue of Akron Life magazine will again have a large section about Kent. After
 a successful advertising collaborative last year, we decided to do it again in 2013. This will create great
 exposure for Kent, and is an example of more "group efforts" we are trying to garnish with our partners.
- <u>"Shop Kent" Campaign</u> Scheduled for late November, Main Street Kent is coordinating a tabloid section
 to go in the Record Courier publications. This will focus on the reasons to shop locally, and feature
 advertisements from local businesses, to promote shopping, dining and entertainment in downtown Kent.

Design/Downtown Beautification

Adopt-A-Spot – Recruited more volunteers to participate in this growing program. The number of hanging
baskets increased to 79 this year, and some new flower beds were added as well, expanding up the new
part of Erie Street. Heritage Ohio recognized Main Street Kent with an award for "Best Beautification
Project" at the Annual Heritage Ohio Awards ceremony.







<u>Downtown Clean-Up</u> – April 27: Designated clean-up day for downtown – over fifty people volunteered their time to help, from various businesses and community groups: Habitat for Humanity, Kent Jaycees, Rotary Club of Kent, Gracylane, KSU Center for Student Involvement, Ametek, Hometown Bank, Portage Foundation, and more. Plans are in the works to schedule more clean-up days this fall and next spring.







- Graffiti Clean-Up Ongoing efforts to remove graffiti in the downtown area through volunteers.
- <u>Alley Clean-Up</u> Worked with building owners to commit to using trash containers rather than plastic bags, consolidate grease containers, regularly power wash alley, remove gum, etc. Also worked with city to get broken railing fixed. It looks much better!
- <u>Mural Project</u> identified graffiti laden area, and worked with building owner, artist, Architectural Review Board, city service department, and other stakeholders from conception through completion. This project has already spurred interest in other building owners, and we hope to do more in the spring.





Holiday Lights – In 2012, we collected \$50,000 to purchase holiday lights for downtown Kent. About one
third of these decorations were not yet installed due to construction, so they will go up this year. We've
secured an additional \$16,000 collaborative investment this year for additional holiday lights and
decorating materials. We're working with the city and Davey on plans to install decorations in November.

<u>Volunteerism</u> – We have been working hard to recruit volunteers to participate on committees, help with projects and programs, and work at our events. The count below includes committee and board meetings, activities, tasks, and events coordinated by Main Street Kent.

STATUS OF APPLICANT:

The applicants are the owners of the property.

REQUESTED ACTION:

The applicants are requesting an appeal of the City of Kent Building Official's decision to condemn the property and schedule the building for demolition, as per Ohio Revised

Code 1.08(B)(2g-h).

ZONING:

This property is currently located in the R-2: Medium

Density Residential Zone District.

TRAFFIC:

The property is accessible from Laurel Drive.

SURROUNDING LAND USES:

The property is surrounded by other residential uses on all

sides.

APPLICABLE CODE SECTION:

ORC 1.08(B)(2g-h)

ANALYSIS:

This property is located at 492 Laurel Drive and is currently zoned R-2: Medium Density Residential. This property is currently a vacant, single family home.

The property owner is requesting an appeal to the Building Official's order to demolish the house due to blighted conditions. The applicant objects to this order stating this order is in violation of their constitutional rights. The applicant states that the order is not consistent with the Ohio Revised Code, that this property is not in violation with the ORC or the City of Kent 930 Overholt Rd., Kent, Ohio 44240 • (330) 678-8108 fax (330) 678-8030 • www.KentOhio.org

Municipal Code, and that this property can be repaired. The applicant explains that they intend to repair the structure and remedy any violations on the property.

A fire occurred at this property on November 24, 2009. The only permit issued after the fire has been for a plumbing permit for a hose bib connection in September of 2011. No other permits have been issued for any repairs of the structure. A letter by the Building Official was sent to the owner of the property on May 31, 2013 that explained two violations, based on the Ohio Revised Code: The property contains a vacant or abandoned structure and the water service has been disconnected since at least May of 2008. There are letters in the file for high grass and weed violations and a letter dated August of 2010 from a neighbor complaining about the condition of the house and property. The following is a timeline of events for the property, based on information in the Building Department address files:

5/22/08	Water Service disconnected
6/12/09	High grass and weeds violation letter sent to property owners
11/24/09	Fire occurred at property
4/9/10	Unsafe structure placard posted on property
8/5/10	Letter to the Health Department from a neighbor complaining about the condition of the property - fire damage, graffiti on house, and animal infestations.
9/14/11	Plumbing permit issued for hose bib connection
5/29/13	High grass and weeds violation letter sent to property owners
6/11/13	Civil Infraction fine letter sent to property owners regarding the high grass and weeds
6/31/13	Letter sent to property owner stating the adjudication order #13-12 for demolition

UPDATE SINCE SEPTEMBER 16, 2013 MEETING

At the September hearing, the applicant submitted a written statement that said the house would be habitable by October 31, 2013. On September 18, 2013, an electric permit was issued to replace the panel and alter the electric. A final inspection was approved on October 30, 2013. On September 20, 2013, an HVAC permit was issued to replace the furnace. An inspection was done on September 25, 2013 and the work was approved. The building official did a final building inspection on October 31, 2013 and approved the structure for occupancy.
