Chief Tosko has provided a copy of the fire and emergency medical services report for November 2020. In 2020 calls for fire service are down 14% (152 calls); fire mutual aid assistance is up by 4 calls as compared to 2019; and EMS responses are down 8% (241 calls). (attachment)
