Unauthorized Items

Information Items

1. Public Safety Advisory Committee Meeting

Bill Lillich has scheduled the October Citizens Public Safety Advisory Committee meeting for October 19th at 7:30 am at the Fire Station. For the October meeting the staff will be reviewing the community outreach programs used by the Kent Police to improve neighborhood relations and enhance public safety. (attachment)

2. Health Board Meeting Minutes and Department Statistics

John Ferlito has provided copies of the health board agenda (for the October 12th meeting) and the statistical report for September 2010. I would point out that the Mayor from Ravenna is on the agenda to speak to the Health Board concerning possible cooperative/joint public health efforts. Health Department revenues and permits are up 9% (\$15,900) in 2010 from 2009. (attachment)
