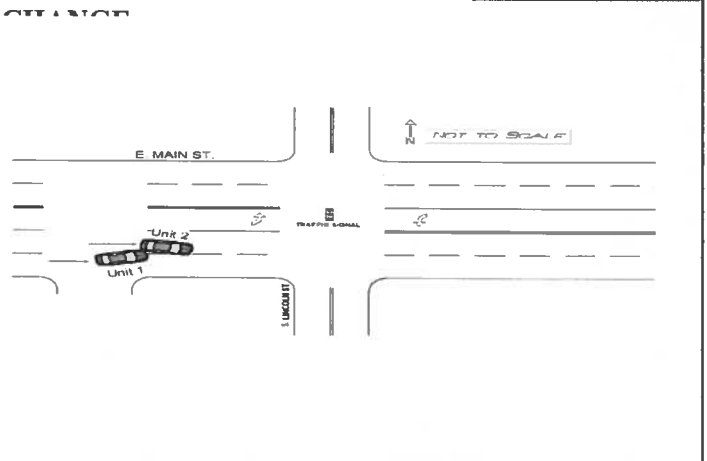
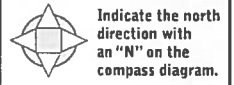

UNIT 2 WAS TRAVELING EASTBOUND ON E. MAIN ST. IN THE LEFT HAND LANE AND BEGAN TO CHANGE LANES TO THE RIGHT HAND LANE. UNIT 1 WAS TRAVELING EASTBOUND ON E. MAIN ST. IN THE RIGHT HAND LANE BEHIND ANOTHER VEHICLE THAT WAS MAKING A TURN INTO A PARKING LOT. UNIT 1 ACCELERATED THE VEHICLE AND SWERVED INTO THE LEFT HAND LANE STRIKING UNIT 2.
