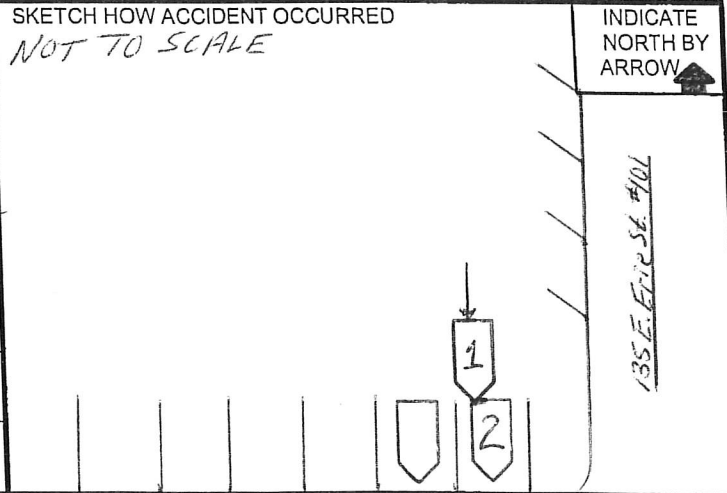

DESCRIBE HOW ACCIDENT OCCURRED
 Unit 2 was parked 9/8 next to 135 E. Erie St. #101 unoccupied. Unit 1 was traveling 9/8 in same parking lot behind Unit 2. The lot was snow and ice covered. Unit 1 failed to stop and slid into the rear of Unit 2. Unit 1 attempted to gain control and then parked near Unit 2. The driver of Unit 1 never exited the vehicle and then fled the scene.

Surveillance video obtained from Woodsy's shows the offense. Unit 1 was left 6 voicemails and finally contacted Ofc. Fuller on 12-11-24. He will be issued hit skip citation. Video placed in KPDE Evidence P: Drive.
