Re: 2024 Individual and Joint Equipment Grant

Dave,

Turnout Gear is an important part of the safety equipment firefighters need to perform their jobs. Each year the fire department must replace some sets of gear based on their age and condition. This year some grant monies have become available through the State of Ohio Department of Commerce. A grant called the Individual and Joint Equipment Grant aims to offset some of the costs of the replacement for fire departments. There is a max of \$15,000.00 available for the grant award. A limitation to this grant is serving a population under 25,000 people. This could be achieved by applying as the emergency service provider of Franklin Township.
