ORDINANCE NO. 2019 - 101

AN ORDINANCE AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO APPROVE A NEW SPECIAL EVENT APPLICATION FROM THE CITY OF KENT AND KENT STATE UNIVERSITY FOR THE 2019 KENT CREATIVITY FESTIVAL "PLAN B" TO BE HELD ON SATURDAY. SEPTEMBER 28, 2019, AND THE TEMPORARY CLOSURE OF ERIE STREET BETWEEN HAYMAKER PARKWAY AND DEPEYSTER STREET, ERIE STREET BETWEEN DEPEYSTER STREET AND WATER STREET, AND A PORTION OF THE SOUTH WATER STREET PARKING LOT, A "PLAN B" FOR GREEN ENERGY OHIO TOUR-CLEAN TRANSPORTATION DRIVE-IN SCHEDULED TO BE HELD IN CONJUNCTION WITH KENT CREATIVITY FESTIVAL AND DECLARING AN EMERGENCY.

WHEREAS, the Kent Creativity Festival "Plan B" location is a precautionary measure in the event that this year's festival cannot be held on campus grounds; and

WHEREAS, the "Plan B" location would temporarily close Erie Street between Haymaker Parkway and Depevster Street and Erie Street between Depeyster Street and Water Street beginning at 7 a.m. on Saturday, September 28th and continue until 6 p.m. that evening; and

WHEREAS, additionally, the Green Energy Ohio Tour-Clean Transportation Drive-In is scheduled to be held in conjunction with Kent Creativity Festival in the parking lot of the City Health Department office on KSU's campus. A proposed precautionary "Plan B" location for the Clean Transportation Drive-In is in the South Water Street Parking Lot; and

WHEREAS, the Kent City Council consents to authorizing the City Manager or his designee to sign the Special Event Application as long as he is comfortable and believes the safety and security of the City's citizens will not be adversely affected; and

WHEREAS, the time is of the essence as the event is scheduled for September 28, 2019.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, at least three-fourths (3/4) of all members elected thereto concurring:

That the Kent City Council authorizes the City Manager or his designee to execute the Special Event Application from the City of Kent and Kent State University in substantial conformance with the Special Event Application attached hereto as Exhibit "A", as long as the City Manager or his designee believes the safety and security of Kent's citizens are adequately protected and authorizing a "Plan B" for the Green Energy Ohio Tour-Clean Transportation Drive-In.

That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121,22 of the Ohio Revised Code.

That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.




