ORDINANCE NO. 2023 -070

AN ORDINANCE AUTHORIZING THE CITY OF KENT HEALTH DEPARTMENT TO ACCEPT THE AWARDED HEALTH EATING AND ACTIVE LIVING GRANT (HEAL) FOR 2024, AND DECLARING AN EMERGENCY.

WHEREAS, the Health Eating and Active Living grant (HEAL) has been awarded and extended for 2024 to the City of Kent Health Department. The grant from 2022 has been increased to \$25,000; and

WHEREAS, the funds will be used for healthy eating and active living program; and

WHEREAS, the City wishes to accept said grant.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio:

<u>SECTION 1.</u> That Kent City Council accepts the awarded Health Eating and Active Living grant (HEAL) extended for 2024 in the amount of \$25,000, execution of the subsequent agreement, and authorized that the Administration provide all information, funds, and documentation required in said applications for submission.

<u>SECTION 2.</u> That the Kent City Council hereby approves the City's acceptance of the grant, if awarded to the City, with corresponding appropriations for its use.

<u>SECTION 3.</u> That the Kent City Council hereby understands and agrees that participation in the program will require compliance with program guidelines and assurances.

<u>SECTION 4.</u> That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 5.</u> That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
