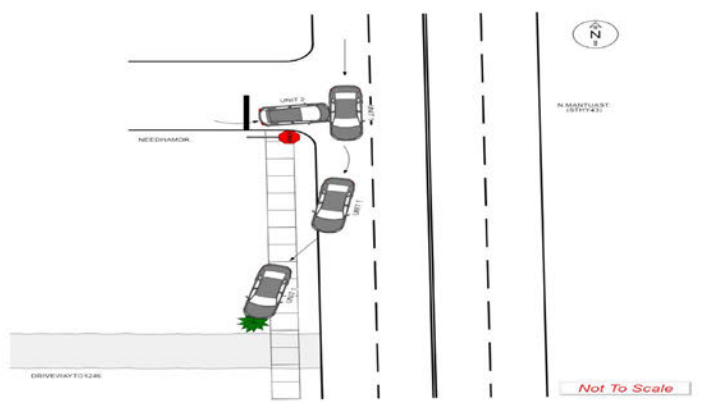
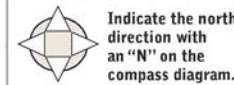

UNIT ONE WAS TRAVELING SOUTHBOUND ON N. MANTUA ST. PASSING NEEDHAM DR. UNIT TWO WAS TRAVELING EASTBOUND ON NEEDHAM AVE. AND STOPPED AT THE STOP SIGN AT N. MANTUA ST. UNIT TWO FAILED TO YIELD FROM THE STOP SIGN, STRIKING THE SIDE OF UNIT ONE. THE FORCE OF THE IMPACT CAUSED UNIT ONE TO RUN OFF THE ROAD RIGHT, STRIKING A CURB AND CONTINUING NORTHBOUND THROUGH FRONT YARDS. UNIT ONE STUCK A SHRUB IN THE

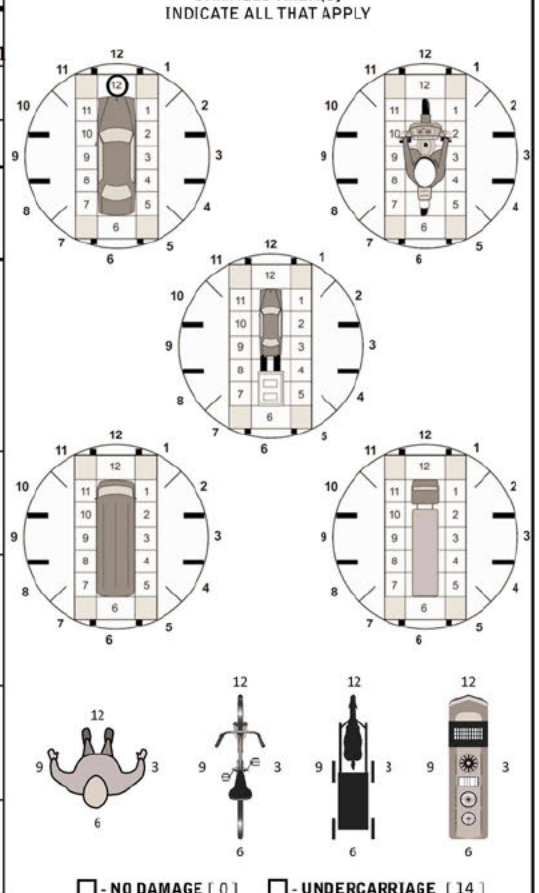

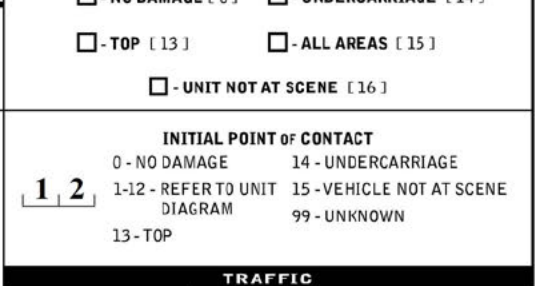
