

## 1. Fire Incident Report

Chief Tosko has provided a copy of the fire and emergency medical services report for June 2017. In 2017 calls for fire service are down 1% (4 calls); fire mutual aid assistance is up 1 event in 2017; and EMS responses are up 8% (141 calls). (attachment)

### 2. Compassionate Services Referral Guide

At the suggestion of a local retail store manager, a referral guide was developed to assist employees connect customers in-need with support services available in Kent and Portage County. Areas of focus include Family, Wellness, and Mental Health Services, Youth Services, Housing Services, Workforce Development, Financial and Legal Services, Kent City Services, and Kent State University Services.
