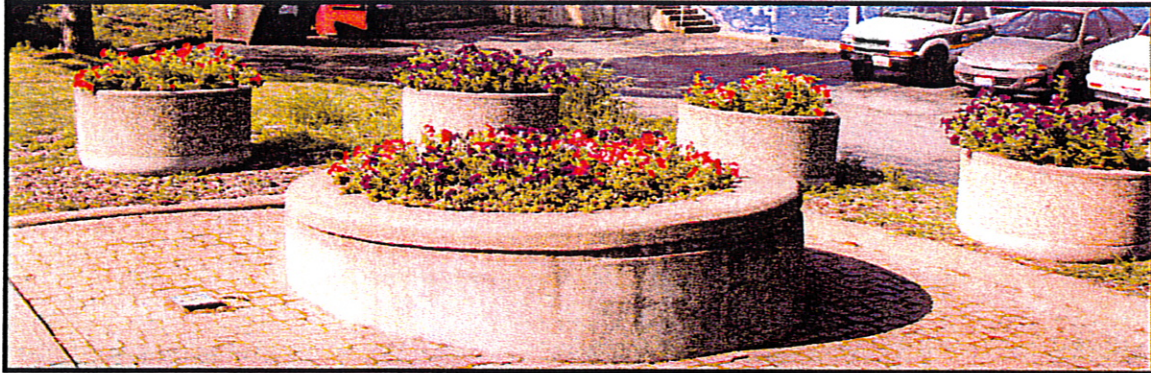

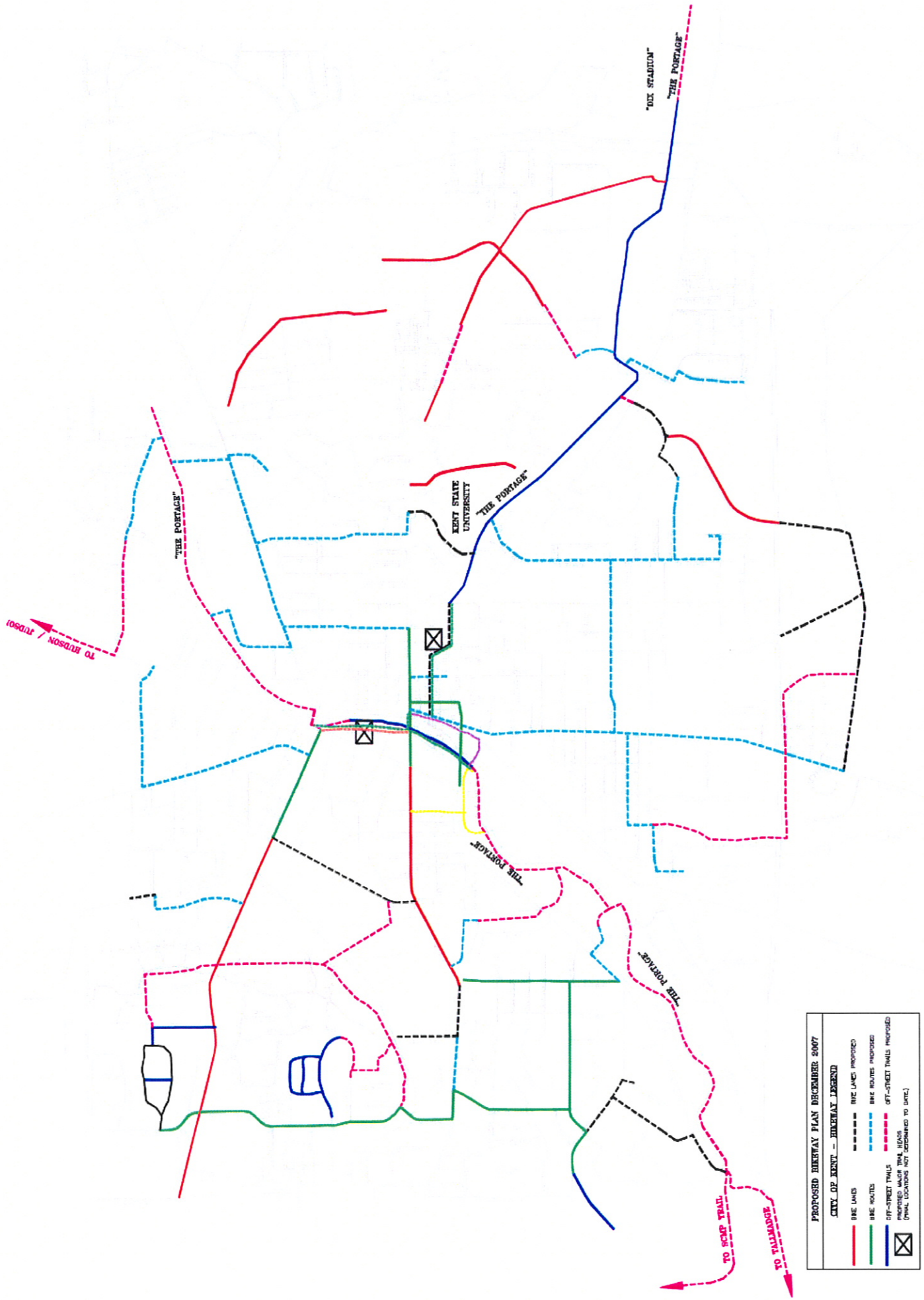

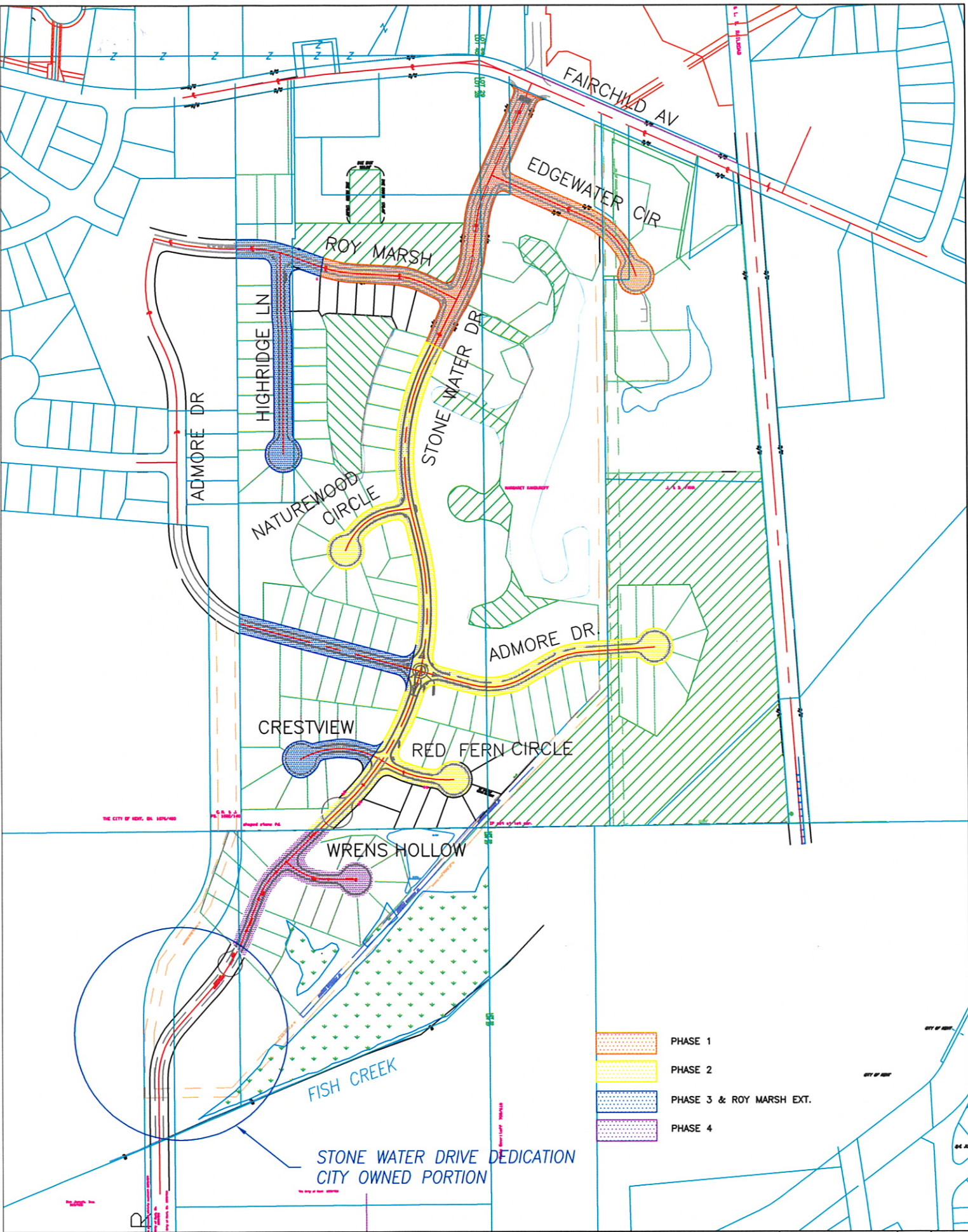

I hereby respectfully request City Council agenda time on October 1, 2008 for the dedication of **Stone Water Drive right-of-way**.

The developer of the Lakes of Franklin Mills (Robert Heimann) constructed this section of road on City of Kent property as part of a land swap deal for the Phase 4 property. The road is now complete and the City is requesting that the right-of-way be split and dedicated as such from the rest of the parcel. This will delineate the road from the rest of the property that is currently parkland, and thus demarcate the area for vehicular travel and road operations and maintenance.
