# 2. Replat and Vacation For Tonkin Street Reconstruction

### 5. Berardinelli and Kent Parks and Rec Land Sale

# 7. Ohio Public Works Commission Pre-Application Request

Jim Bowling has requested Committee time for Council to consider approving submission the City's capital project pre-application request for Ohio Public Works Commission grant and loan funding in the combined loan and grant amount of \$500,000 for the City's \$3 million signal project on \$R43, and \$390,000 for the \$832,000 Valleyview/Morris water & stormwater improvement projects. ## Administration Recommendation

These 2 projects are already approved and funded in the City's Capital Plan. If the City is successful in securing OPWC funds that would free-up the City's capital funds already allocated to these projects which can then be redirected towards other critical capital projects that underfunded. Given the City's current financial constraints I have encouraged staff to pursue all possible grant sources and Jim has put together a competitive proposal that I recommend for Council's support.

## 8. Trex Liquor License Partial Ownership Change



# Information Items

## Income Tax Report

Dave Coffee has provided a summary of income tax collections thru the end of April 2016. Overall the City income tax collections are up 3.55% (\$166,305) from April 2016. Kent State University's collections thru the end of April are up 2.19% (\$35,877). (attachment)

### Kent Police Statistics

Chief Lee has provided a copy of the police statistics report for April 2016. In 2016 calls for service are up 24% (2,416 calls); traffic citations are up 8% (102 tickets); accident incidents are up 1% (20 incidents) and serious crimes are down 20% (46 cases). (attachment)
