Information Items

1. Kent Police Statistics

Chief Lee has provided a copy of the police statistics report for January 2018. In 2018 calls for service are down 20% (454 calls); traffic citations are down 25% (68 tickets); accident incidents are up 16% (12 incidents) and serious crimes are down 16% (9 cases). (attachment)

Chief Lee has provided a copy of the police statistics report for December 2017. In 2017 calls for service are down 10% (2,844 calls); traffic citations are down 19% (667 tickets); accident incidents are down 26% (262 incidents) and serious crimes are down 13% (94 cases). (attachment)

2. Fire Incident Report

Chief Tosko has provided a copy of the fire and emergency medical services report for December 2017. In 2017 calls for fire service are up 8% (80 calls); fire mutual aid assistance is down 6 events in 2017; and EMS responses are up 4% (145 calls). (attachment)

3. Health Department Statistics

Jeff Neistadt has provided a copy of the statistical report for January 2018. Health Department revenues are down 29% (\$11,329.22) and permits are up 4% (1 permit) in 2018 from 2017. (attachment)

Jeff Neistadt has provided a copy of the statistical report for December 2017. Health Department revenues are up 10% (\$58,779.75) and permits are down 7% (41 permits) in 2017 from 2016. (attachment)

4. Monthly Permit and Zoning Reports

Bridget Susel has enclosed copies of the monthly zoning and permit violations report for January 2018. Permit revenues were \$27,757.22 for January with the most permits being issued for Plumbing Residential (18 permits). There were 65 code enforcement items in January. (attachment)
